A. Covid-19 Review back to School plan

Following a lengthy discussion, the board passed a motion to modify our back-to-school COVID plan. Starting immediately, the following changes are in effect:

- Students with multiple COVID symptoms will continue to be sent home and will not be allowed to return before the end of the mandatory 10 isolation period, unless they can show us a negative test result that was conducted by a healthcare provider, or they have a doctor's note indicating the child suffers from another chronic medical condition that will allow them to attend school.
- The principals will screen students and discuss their symptoms with their families before making the decision to send them home.
- We will no longer be conducting the close contact tracing at school. Instead, we will be notifying designated families when a student tests positive for COVID. Parents will be expected to monitor their own children. They will be making the decision as to whether or not they feel their child is a close contact and should remain home, or whether or not they want their child to attend school.
- Masking of all staff and students remains encouraged, but optional.

Louise Cody motioned and Shannon Berg seconded to modify our back to school COVID plan as described above. Motion carried 5-0.
